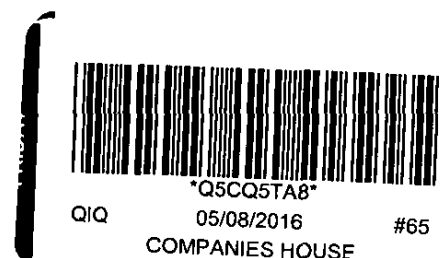
**UPON THE PETITION OF** National Aluminium Company Limited, a creditor of the
