Report of the Director for the year ended 31st January 2010

The director submits his report, together with audited financial statements for the year ended 31st January 2010

Structure, Governance and Management

Island Concerts Limited is a registered charity number 1019518

The sole director is R Milner Esq who is responsible for the direction and management of the charity

Objectives and Activities

The principal activities are to promote, improve, develop and maintain public education in and appreciation of music by the organisation of public concerts, mainly on the Isle of Wight, by professional orchestras and musicians

Achievements, Performance and Financial Review

This report covers the fifth year of trading as a registered charity from 1st February 2009 to 31st January 2010

For the third year running we staged a concert by the Royal British Legion Central Band under the direction of Captain David Cole at the Cowes Yacht Haven Events Centre on Friday 24th April 2009, featuring the soprano soloist Margaret Threadgold and the Yarmouth based Slipshod singers. A reasonable surplus was made which was shared equally with the charities of the Rotary Club of Cowes

During this period Sinfonietta concerts were staged on Friday 9th October and on Friday 11th December 2009 at our usual venue of All Saints Church, Ryde The October concert featured soloist Matthieu Petitjean, winner of the 2009 International Oboe Competition held in the Isle of Man, who played the Oboe concertos by Bach and Marcello The December concert featured 'back from injury' Lionel Handy with a remarkable performance of Haydn's Cello Concerto in C

Island Concerts also provided marketing support for a number of other events including Wolverton Manor and Ventnor recitals and for the first time, a jazz concert featuring Alan Barnes (Saxophone and Clarinet) and Bruce Adams (Trumpet and Flugel Horn) at the Royal London Yacht Club on 25th April 2009

Thanks again go to our supporting sponsors, principally the Isle of Wight County Press and Crossprint Wightlink Ferries and, again this year, the Daisie Rich Trust who provided valuable assistance in the form of a grant. However, the Isle of Wight Council withdrew their support due to lack of funding. The October Sinfonietta concert had to be subsidised significantly from Island Concerts' reserves, perhaps indicating the effect of the recession is having on discretionary spending by audiences. A decision was taken subsequently not to stage a concert in October in 2010.

But it is our core patrons who provide the major support including to The Sinfonietta, directed by Richard Studt, with their professional performances on the Island
