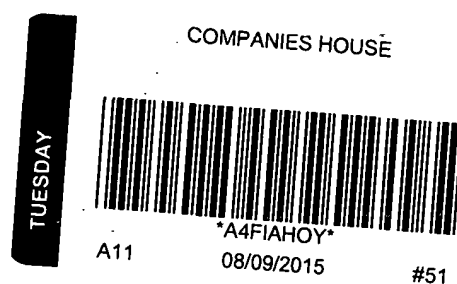

The directors present their annual report on the affairs of the company, together with the unaudited financial statements, for the year ended 31 March 2015.


#### **Business Review**


