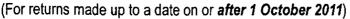

A Ordinary Shares

The holder of the 'A' ordinary shares shall be entitled to receive notice of, or attend, or vote at any general meeting of the Company.

The 'A' ordinary shares shall rank pari passu with regard to entitlement to dividend except that the directors may at any time resolve to declare a dividend on one class of share and not the other class of share

- (III) next and subject to (i) and (II) above, the balance of such assets shall belong to and be distributed amongst the holders of the ordinary shares and the 'A' ordinary shares in proportion to the amounts paid up or credited as paid up thereon,

B Ordinary shares

The 'B' ordinary shares shall rank pari passu with regard to entitlement to dividend except that the directors may at any time resolve to declare a dividend on one class of share and not the other class of share

On return of assets on liquidation, reduction of capital or otherwise, the surplus assets of the company remaining after payment of its liabilities shall be applied

- (iv) first in paying to the holders of the ordinary shares and the 'A' ordinary shares and amount per share equal to the sum paid up or credited as paid up thereon;
- (v) next and subject to (1) above, in paying to the holders of the 'B' ordinary shares an amount per share equal to the sum paid up or credited as paid up thereon;
- (vi) next and subject to (i) and (ii) above, the balance of such assets shall belong to and be distributed amongst the holders of the ordinary shares and the 'A' ordinary shares in proportion to the amounts paid up or credited as paid up thereon,
