**DIRECTORS' REPORT**

The directors present their annual report and the audited financial statements for the eleven month period ended 30 September 1997.

ACTIVITIES

The principal activity of the company is steel stockholding. Throughout the period the company acted as an agent for Barrett Steel Limited. All transactions entered into have been transferred to Barrett Steel Limited in accordance with the terms of the agency agreement.

DIVIDENDS AND TRANSFERS TO RESERVES

The results of the company for the period are set out in the profit and loss account on page 5. The directors do not recommend the payment of a dividend for the period (1996 : £Nil) and, as a result of the transfer of all transactions to Barrett Steel Limited, the company made neither a profit nor a loss in the financial period (1996 : £Nil).

1. ACCOUNTING POLICIES
