## Director's Report

For the year ended 31 March 2017

The Directors submit their report together with the financial statements for the year ended 31 March 2017.

The company has met the requirements of the Companies Act 2006 to obtain the exemption provided from the presentation of a strategic report.

### Business Activity

Fujitsu Services (Finance) Limited ("the Company") has not traded during the year and is not expected to do so in the foreseeable future. The Company was dormant within the meaning of section 480 of the Companies Act 2006 throughout the year ended 31 March 2017.

The Company made a profit for the year of £nil (2016: £nil.).

### Directors' Interests

The Directors in office at 31 March 2017 did not have any interests in or options over shares or debentures of the Company or of any other group company, which are required to be entered in the Register of Directors' Interests.

There are no contracts in relation to the Company's business in which the Director has a material interest.

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.



## Notes to the Financial Statements

### 1 Accounting Policies

---

The Company is a company incorporated and domiciled in England and Wales.

The financial statements of the Company for the year ended 31 March 2017 have been prepared and approved by the Directors in accordance with International Financial Reporting Standards as adopted by the European Union ("Adopted IFRSs").

The accounting policies set out below have, unless otherwise stated, been applied consistently in all periods presented in these financial statements.

The financial statements were authorised for issue by the Directors on 28<sup>th</sup> September 2017.

#### Basis of Preparation

The financial statements are prepared on the historical cost basis except that the following assets and liabilities are stated at their fair value; derivative financial instruments, financial instruments held for trading, and financial instruments classified as available for sale. Non-current assets and disposal groups held for sale are stated at the lower of previous carrying amount and fair value less costs to sell.

The accounting policies set out below have, unless otherwise stated, been applied consistently to all periods presented in these consolidated financial statements.
