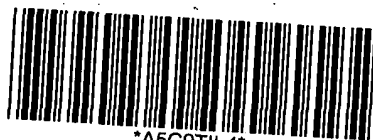

The company is based in the United Kingdom and has not traded during the current or preceding financial year, and accordingly no profit and loss account has been prepared.


