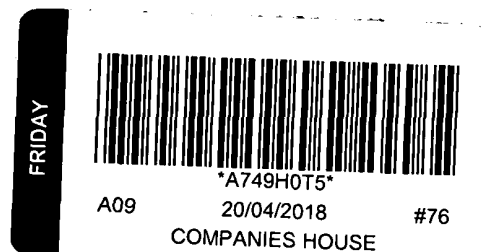

Statement of directors' responsibilities in respect of the directors' report and the financial statements

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year. Under that law they have elected to prepare the Financial Statements in accordance with UK Accounting Standards and applicable law (UK Generally Accepted Accounting Practice) including FRS 101 *Reduced Disclosure Framework*.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the company and to prevent and detect fraud and other irregularities.

1 Accounting policies

The Company is a private company incorporated, domiciled and registered in the UK. The registered number is 02802237 and the registered address is One Southampton Row, London, United Kingdom, WC1B 5HA.

These financial statements were prepared in accordance with Financial Reporting Standard 101 *The Reduced Disclosure Framework* ("FRS 101") as issued in August 2014.

The presentation currency of these financial statements is sterling. All amounts in the financial statements have been rounded to the nearest £1.

The Company proposes to continue to adopt the reduced disclosure framework of FRS 101 in its next financial statements.

A profit and loss account has not been prepared as the Company did not trade and received no income nor incurred any expenditure during the current or previous financial year.

4 Ultimate parent company and ultimate controlling party

The company's ultimate parent company and controlling party is Sodexo SA, a company incorporated in France.
