

## **NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2021**

### **1. STATUTORY INFORMATION**

The company is a private company, limited by shares, registered in England and Wales. The address of the registered office is given on page 1.

### **2. ACCOUNTING POLICIES**

#### **Basis of preparation**

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### **Income statement**

The company is dormant as defined by section 1169 of the Companies Act 2006. The company received no income and incurred no expenditure during the current year or prior year and therefore no income statement is presented within these financial statements. There have been no movements in members funds during the current year or prior year.

#### **Trademark**

The company holds a trademark but it was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the year ended 31 December 2021.

### **3. ULTIMATE PARENT COMPANY**

The Company is a wholly owned subsidiary of Edwardian Group Limited, a Company registered in England and Wales, which is also the ultimate parent and controlling Company of the group.

Verite Trust Company Limited as trustee of a number of trusts established in Jersey of which Mr Jasinder Singh, a director, and his family are discretionary beneficiaries, hold 86.07% (2020: 86.07%) of the ordinary shares in the ultimate parent and is thus considered as controlling the ultimate parent in its capacity as a trustee (2020: the shares were held jointly by Verite Trust Company Limited and Jemma Trust Company Limited. Jemma Trust Company Limited retired as joint trustees on 1 July 2021). Mr Jasinder Singh owns 6.89% (2020: 6.89%) of the ordinary shares in the ultimate parent personally.

These financial statements have been consolidated in the financial statements of Edwardian Group Limited, which is the only group in which the results of the Company are consolidated. The consolidated financial statements can be obtained from 140 Bath Road, Hayes, Middlesex, UB3 5AW.
