Explanatory Statement

The current Articles provide that the number of Trustees shall be not less than 10 and that where there are fewer than 10, the Board can only act for the purpose of filling vacancies or calling general meetings.

The resignation of Sir Mark Allen and the decision by Professor Margaret Johnson not to stand for reelection at the AGM on 26 October 2023 means that the Board of Trustees will be 9 in number.

The proposed amendment to the Articles will enable the Board to continue to perform the full remit of its duties whilst also filling the vacancies on the Board. The Board considers this to be in the best interests of the charity. The minimum number of Trustees can be increased again in due course, as part of a planned full review of the Articles, should this be deemed appropriate.
