To extend and replace the authority originally granted under on the Company's articles of association on 21 November 2017 and the authority granted on 9 November 2018 by resolution circulated on 15 October 2018, THAT, in accordance with section 551 of the Companies Act 2006, the directors of the Company be generally and unconditionally authorised to grant rights to subscribe for shares in the Company as part of share option agreements, and to subsequently allot such shares, provided that there shall at no time be share options in place covering shares with an aggregate nominal value of more than £321,329 and provided that this authority shall, unless renewed, varied or revoked by the Company, expire five years after the date of this resolution. For the avoidance of doubt, as long as valid option agreements are entered into within this period, the shares do not have to be allotted within this period and may be allotted after its expiration and still be valid for the purposes of this authority.
