

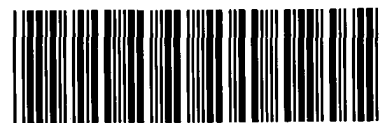

**1. GENERAL INFORMATION**

Bath Royal Literary and Scientific Institution Trustees is a company limited by guarantee, incorporated in England and Wales. The registered office is 16-18 Queen Square, Bath, BA1 2HN.

**2. ACCOUNTING POLICIES**

**2.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS**
