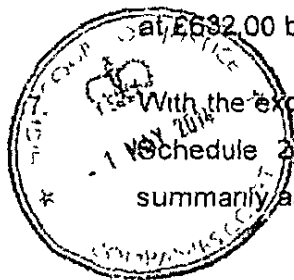

- 2 That each of the Respondents be replaced as such office-holder in the case of each such estate referred to in Schedule 2 by the Applicants named in **Schedule 1** attached to this Order as his/her proposed replacement, these replacements to take effect on 30 June 2014
- 3 Each of the Respondents shall be released from all liability pursuant to the relevant sections of the Insolvency Act 1986 in respect of their acts and omissions and otherwise in respect of their conduct as liquidator (voluntary or compulsory, as the case may be) of the companies listed as being in compulsory liquidation and members' voluntary liquidation (Schedule 2), in the case of each Respondent such release to take effect in relation to each relevant estate 28 days after the date of the report or routine report referred to in paragraph 5 2 of this Order, or earlier if appropriate

- 6 In respect of the compulsory liquidation estate (as listed at number 1 of Schedule 2), the costs of this Application (including disbursements and VAT) summarily assessed at £632.00 be borne by PricewaterhouseCoopers LLP
 - 6 1 With the exception of the compulsory liquidation estate (as listed at number 1 of the Schedule 2), the costs of this Application (including disbursements and VAT) summarily assessed at £10,109.00 be aggregated and apportioned equally between



each of the estates listed in Schedule 2, provided that if the costs which fall to be borne by any one of the estates exceeds 10% of the realisable assets within that estate, that estate shall only bear such part of those apportioned costs as equals 10% of that estate's readily realisable assets, and the excess shall be borne by PricewaterhouseCoopers LLP.
