**Proposal for reduction of share capital and share premium**

Thorn Security Group Limited (the "**Company**") is proposing that:

- (a) the share capital of the Company be reduced from £11,096,674 made up of 11,096,674 Ordinary shares of £1.00 each, by cancelling 11,096,673 Ordinary shares of £1.00 each, and the amount by which the share capital is reduced (being £11,096,673.00), be credited to the Company's profit and loss account to be treated as realised profit; and
- (b) the share premium account of the Company of £7,772,030 be cancelled and extinguished and be credited to a reserve which is to be treated as realised profit.
