



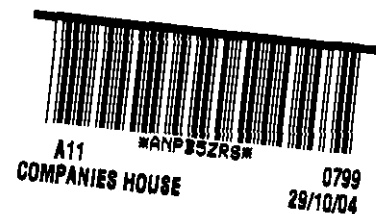

The company did not trade and was dormant throughout the year.


