LIQUIDATOR'S ACTIONS SINCE LAST REPORT

Since my last report to creditors I have continued to investigate into the affairs of the company, the reason behind its financial position and the conduct of the Directors.

My investigations remain ongoing.

There is certain work that I am required by the insolvency legislation to undertake in connection with the liquidation that provides no financial benefit for the creditors. A description of the routine work undertaken since my last progress report is contained in Appendix 1.

RECEIPTS AND PAYMENTS

My Receipts & Payments Account for the period from 9 November 2019 to 8 November 2020 is attached at Appendix 2.

Receipts

There has been no receipts during this period.

Payments

Bank Charges

The sum of £88.00 has been paid to the Insolvency Service Administration in respect to quarterly charges at a rate of £22 per quarter.

LIABILITIES

Secured Creditors

An examination of the Company's mortgage register held by the Registrar of Companies, showed that the Company has no current charges over its assets.

The legislation requires that if the Company has created a floating charge after 15 September 2003, a prescribed part of the Company's net property (i.e. the money that would otherwise be available to the charge holder) should be ring-fenced for distribution to unsecured creditors. In this case there were no creditors secured by a floating charge such that the prescribed part provisions do not apply.

Preferential Creditors

The statement of affairs anticipated no preferential creditors. No claims have been received.

Crown Creditors

HMRC's claim of £731,423.38 has been received.

Non-preferential unsecured Creditors (Excluding HMRC)

The statement of affairs did not include any non-preferential unsecured creditors. I have not yet received any claims

DIVIDEND PROSPECTS

Based upon the information currently available there will be no dividend to the unsecured creditors.

INVESTIGATION INTO THE AFFAIRS OF THE COMPANY

I undertook an initial investigation into the Company's affairs to establish whether there were any potential asset recoveries or conduct matters that justified further investigation, taking account of the public interest, potential recoveries, the funds likely to be available to fund an investigation, and the costs involved.

As stated previously, my investigations into the affairs of the Company remain ongoing.

LIQUIDATOR'S REMUNERATION

My remuneration has yet to be agreed with creditors.

My total time costs to 8 November 2020 amount to £4,622.50, representing 21.80 of hours work at a blended charge out rate of £212.04 per hour. Of which, £2,238.50, representing 1080 hours worked at a blended charge out rate of £207.27 has been incurred since the last progress report. I have not been able to draw any remuneration in this matter as the basis of my remuneration has not yet been fixed by creditors.

FURTHER INFORMATION

An unsecured creditor may, with the permission of the Court, or with the concurrence of 5% in value of the unsecured creditors (including the creditor in question), request further details of the Liquidator's remuneration and expenses within 21 days of their receipt of this report. Any secured creditor may request the same details in the same time limit.

An unsecured creditor may, with the permission of the Court, or with the concurrence of 10% in value of the unsecured creditors (including the creditor in question), apply to Court to challenge the amount of remuneration charged by the Liquidator as being excessive, and/or the basis of the Liquidator's remuneration, and/or the amount of the expenses incurred as being excessive, within 8 weeks of their receipt of this report. Any secured creditor may make a similar application to court within the same time limit.

Appendix 1

Administration

- Undertaking regular bank reconciliations of the bank account containing estate funds.
- Reviewing the adequacy of the specific penalty bond on a quarterly basis.
- Undertaking periodic reviews of the progress of the case.
- Overseeing and controlling the work done on the case by case administrators.
- Preparing, reviewing and issuing an annual progress report to creditors and members.
- Filing returns at Companies House.
- Preparing and filing VAT returns.
- Preparing and filing Corporation Tax returns.

Creditors

- Dealing with creditor correspondence, emails and telephone conversations regarding their claims.
- Maintaining up to date creditor information on the case management system.

Investigations

- Conducting an initial investigation with a view to identifying potential asset recoveries by seeking and obtaining information from relevant third parties, such as the bank, accountants, solicitors, etc.
- Reviewing books and records to identify any transactions or actions the office holder may take against a third party in order to recover funds for the benefit of creditors.
