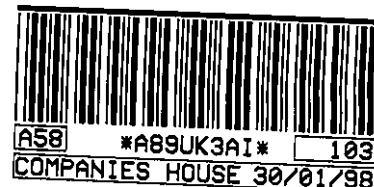

***Director's Report***

***Principal Activities***

The company has not traded during the year, and no trading is in prospect.
