# Trustees' Report

The Trustees, who are also Directors of the charity for the purposes of the Companies Act, present their annual report and audited financial statements for the year ended 31 March 2012. The Trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and reporting by charities (revised 2008)" in preparing the annual report and financial statements of the charity

### Objects and activities

The company is established as a company limited by guarantee under its Memorandum and Articles of Association dated May 1994

The company's charitable aim as set out in its Memorandum of Association is the advancement of education through environmental conservation, protection and restoration for the benefit of the public by the provision of training and information services and the encouragement of participation and volunteering in practical environmental projects. The Trustees have agreed to three working aims

- a) Raising awareness of environmental issues in all sectors of the community,
- b) Increasing participation in environmental projects by individuals and groups,
- c) Promoting change in society towards a more sustainable future

The Environment Centre seeks to achieve its aims through three main aims of activity

- 1) Supporting other environmental groups and projects through a range of facilities and services,
- 11) Providing information services including a public information centre, a resource library, a monthly newsletter, regular features in the media, exhibitions and stands at local events,
- III) Organising educational projects and activities for schools, community groups and the general public

### Organisational structure

The Environment Centre is managed by a Board of Trustees Board meetings are arranged on a bi-monthly basis Sub groups are organised to meet between Board meetings to discuss and progress finance, property & staffing issues, as well as the education & information delivery and outreach issues. These sub groups are made up of trustees, staff and volunteers, and report back to the board

The Centre Manager is responsible for the day to day running of the Centre and provides a detailed activity report to the Board at the Board meetings. The Finance Manager prepares a comprehensive financial report for these meetings.

The Environment Centre is fully independent but works closely with many other organisations and is a member of several forums, partnerships and networks. The most notable of these are the Swansea Environmental Education Forum (SEF), the Swansea Environmental Forum (SEF), the Neath Port Talbot Environmental Forum (NPTEF), Swansea Community Recycling Alliance & Partnership (SCRAP), Swansea Waste Forum, Swansea Council for Voluntary Service (SCVS) and the Swansea Fair Trade Forum on a local level. The Centre is a member of the Better Swansea Alliance

### Review of activities and future developments

Environment Centre staff over the year consisted of Jenny Edwards as Centre Manager, Gareth Evans as Finance Manager, Hannah Mitchell as Resources Officer, Anita Houten as Education Officer & SEEF Coordinator and Mo Green as Caretaker

Under the Future Jobs Fund Scheme (funded by SCVS), Dave Blackwell continued his 6-month term through to the end of July 2011

Placements included Felix Reimann, a student from Germany, Marta Beltrame, a student from Italy and Bethan Herbert-Jones from Swansea Metropolitan University Both foreign students were with us for a few months and Bethan over 9 months on a part-time basis

We had administrative help from Laura Davies in November 2011 in the absence of Hannah Mitchell (wedding & honeymoon, married James Mitchell on 29<sup>th</sup> October 2011) Laura had previously worked with us on placement from Swansea Metropolitan University in April to June 2011

The Sustainable Swansea initiative continued throughout the year with two officers, Dai Power & Delyth Higgins The usual summer Trailblazer events did not take place in 2011 but would be reinstated in 2012

Swansea Community Recycling Alliance Partnership (SCRAP) held meetings throughout the year, which were coordinated by Jenny Edwards in the absence of a designated official

A change was made in the way the Environment Centre received its funding from both CCW and the Swansea Change Fund (formerly Compact) Both applications were done in partnership to give us a better chance to secure funds. Therefore the Environment Centre, Swansea Environmental Forum, Sustainable Swansea and Swansea Environmental Education Forum collaborated to successfully receive funds that enabled each party to carry out their programme of events and activities for the year CCW accepted the partnership application with the Environment Centre as the lead partner (to receive the partnership funds retrospectively via quarterly & interim claims) whilst the Swansea Change Fund partnership application was headed up by the Swansea Environmental Forum (receiving the designated amounts quarterly in advance). The Centre's Education & Activities Program 2011-12 continued and once again included "Blue Ocean Blues" (the marine conservation presentations and exhibition event at the Environment Centre), "Fire Skies" and "World within your Shoe", presented by Phil Williams (Plan-It Eco). Other events in the program included "Ecology Field Studies" at Crymlyn National Nature Reserve, carried out by Dawn Thomas (Nature Days) together with a series of workshops, courses, training events and Insets (various presenters) held at the Environment Centre and other sites e.g. Bishops Wood, Caswell

Fundraising throughout the year included the following events

An evening of "live music" at the Monkey Café took place on 20th May, organised by Hannah

The Swansea 10k Run was held on 25<sup>th</sup> September Congratulations and thank you to all those who completed the run on our behalf

An "Auction" of items was held here on 13th October Thank you to the people that donated items and to those who made bids on the night

We are grateful to Traveline Cymru for their donation/financial support (1st November 2011), which enabled us to produce new leaflets on "Venue Hire" & "About Us"

Outreach events during the year included us taking part at – Wise up to Waste Week at Swansea Community Farm – Bike Week – Clyne Valley Caper Cycle Ride – Fairtrade Fortnight (Evening at Tapestri)– Inset at Bishops Wood Local Nature Reserve (Taking Art Outdoors) – Workshops for Tarnished Earth Exhibition – Presentation to full Council of City and County of Swansea – Preparation and hason around the Eastside Energy Scheme to be launched in June 2012 for St Thomas ward residents on behalf of Swansea Bay Energy Partnership

Events at the Centre included – Insets (Eco Flag) – Training Courses (Sustainable Home Refurbishment, Stained Glass Christmas Crafts, Permaculture & Urban Permaculture Weekend, Understanding Behaviour Change & Clothes Pattern Making) – Workshops (Willow for Kids & Willow Weaving for Adults)

The Green Fayre (at the National Waterfront Museum for the seventh year running) was again organised by Hannah with help from staff, trustees & volunteers. The event was held once again two days on 26<sup>th</sup> & 27<sup>th</sup> November 2011. Thanks to everyone that made the event such a success including 68 great stalls.

Greenlight is our newsletter. We continued with our aim of saving paper by producing fewer printed-paper copies and distributing more as e-versions. The use of emails for distributing information continues to grow and our website <a href="https://www.environmentcentre.org.uk">www.environmentcentre.org.uk</a> has been regularly updated and improved by Jenny Edwards, Centre Manager. We also made use of Face book and email networks for advertising and information distribution.

Exhibitions in our hall throughout the year included – "Blue Ocean Blues", "Conscious Oil", "Fairtrade Fashion Shoot" & "Sculpture by the Sea"

Swansea Environmental Forum (SEF) continues to hold its AGM and other meetings at the Centre SEF is the Strategic partnership for the environment in Swansea and is very active at a local and national level SEF continues to pay the Centre a fee for co-coordinating their forum and projects, which includes the Sustainable Swansea Initiative A new project "Low Carbon Swansea" got underway in February 2012 with a search for a Project Manager The Successful applicant started in April 2012

Swansea Environmental Education Forum (SEEF) activities included the Swansea Sustainable Schools Scheme (SSSS), which has gone from strength to strength, since the awards started Easter 2010. So far 21 schools have been awarded with 24 awards. There have been 4 silver awards, a bronze plus award and 19 bronzes. A gold award is also imminent. SEEF organised three INSET's at the Centre on School Gardening, Environmental Art and Eco Schools, all of which were well attended by Swansea and Neath Port Talbot schools. During this time there were two secondary schools networking meetings in June and February. An after school visit was extended to teachers to visit Ynystawe Primary school in July to look at their school grounds which was a follow up from the successful School Grounds conference, March 2011. Two school visits were organised to the Tarnished Earth exhibition, which Phil Williams ran as part of his workshops for schools. The SEEF website is now a source of information for teachers and is regularly updated. The previous termly green envelope for schools is now put on the website.

It is really important to us that we continue to offer office space within the building to other environmental organisations. We are therefore pleased to continue to provide accommodation in 2012-13 to Undercurrents, Sustainable Swansea Initiative, Swansea Environmental Education Forum (SEEF), One People, Wales Green Business Centre, Groundwork, Amphibian & Reptile Conservation Trust (ARC) & Low Carbon Swansea Bikeability, Bat Conservation Trust (BCT), the More Green Project, Wales Youth for Sustainable Development (WYFSD) & BTCV have left us during the year. The local Friends of the Earth, Bat Conservation Trust & Bikeability continue to use us as their correspondence address.

The valued support of a committed team of volunteers remains an essential aspect of the day-to-day running of the Centre and the delivery of core services. A number have come and gone during the year and many have been with us for some time. To all, we thank them for their help and commitment in the giving of their valuable time.

We continue to improve and maintain the building and in this financial year have installed a brand new Disability Lift to our first floor hall Thanks to Awards for All (Big Lottery Fund) & SCVS (Swansea Development Fund) for their Grant Aid

The Transition Swansea Food Group is now looking after the garden at the Centre Many thanks to them for transforming the outside space using permaculture principles & techniques

We have registered with the Keep Wales Tidy Eco Centre Scheme. This will replace the formal accreditation under the Green Dragon Environmental Award Scheme. As part of this process we have created an Eco Code, new notice board and newsletter. The Centre's Education and Information Group monitor progress.

Future Developments include the repair and renovation of our roof, guttering, windows and rendering during July to September 2012 Thanks to Exall & Jones Ltd for their kind donation in June 2011, which has part financed the building work

Eastside Energy Scheme, a community fund from the Swansea Bay Energy Partnership, will be launched during 2012-13

The trustees have paid due regard to the Charity Commission guidance on public benefit and believe that our activities continue to meet the **public benefit requirement**. The independent Social Audit undertaken by us and independently verified on 21<sup>st</sup> January 2009 further confirms the ways in which our aims and objectives are delivering for the public benefit.

Trustees' report (continued)

#### Reserves

The trustees' policy to maintain reserves equivalent to six months gross salary costs, for staff not funded from restricted fund income, continues. On this basis the level of reserves required is in the order of £26,000. The Centre's total unrestricted fund reserves at 31 March 2012 amounted to £142,918 (a decrease of £5,032 on the previous year) but once again the greater part was represented by fixed assets and therefore illiquid in the short term. The unrestricted fund reserves represented by net current assets amounted to £47,924 and therefore sufficient to meet the trustees' reserves policy.

### Risk Management

The trustees continue to undertake an assessment of risks to which the centre is exposed and are establishing systems to mitigate those risks. This process involves identifying the types of risks to which the Centre is exposed, prioritising risks in terms of their potential impact on the Centre's activities and identifying ways in which the risks might be managed. The trustees recognise that risk assessment is an ongoing process and the process will be reviewed and the quality of the assessment enhanced on a regular basis.

### Review of transactions and financial position

Unrestricted fund income has decreased by some £12,900 over the 2010/11 level, due mainly to a fall in facility recharges, but also with decreased income from fund-raising and hire of accommodation offset by increased donations. Unrestricted fund expenditure has decreased by some £1,600, mainly due to a decrease in the level of project costs offset by a rise in payroll costs not recoverable against grant-supported projects. Overall the outcome on unrestricted funds showed an excess of outgoing over incoming resources of £5,032. The accumulated balance brought forward of £147,950 has been decreased by this excess to leave a balance carried forward of £142,918.

The company's restricted fund income has reduced by some £23,500 from the 2010/11 level due mainly to the cessation of grant support for SCRAP Replacement funding schemes from the City & County of Swansea and the Countryside Council for Wales brought in £5,000 less than in the previous year and the end of the Future Jobs Fund scheme saw a further year-on-year decrease of some £3,000 A grant of £14,000 from the SCVS to add to funds received in the previous year from the Lottery Fund enabled the installation a new disability lift. The decrease of some £33,200 in restricted fund expenditure mirrored the end of expenditure on the SCRAP scheme and the lower funds available for expenditure on the projects supported by the City & County of Swansea and Countryside Council for Wales. The overall result is an excess of incoming over outgoing resources on restricted funds of £12,340. The accumulated balance brought forward of £5,000 has been increased by this excess to leave a balance carried forward of £17,340.

### Notes to the accounts

### 1 Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material to the company's financial statements

### Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities (revised 2008)", the Financial Reporting Standard for Smaller Entities (effective April 2008) and the Charities Act 1993 There has been no change to the accounting policies since last year

#### Company status

The Environment Centre Ltd is a company limited by guarantee In the event of the winding up of the company every member is liable to contribute to the debts and liabilities of the company such amounts as may be required, but not exceeding £10 each

### Fund accounting

Unrestricted funds are funds available for use at the discretion of the trustees in furtherance of the general objectives of the charity

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors

#### Incoming resources

Incoming resources are included in the statement of financial activities when the charity is entitled to the income. Grants received for the general purpose of managing and administering the company in furtherance of its general objects are accounted for as unrestricted funds. Grants for specific purposes given under donor-imposed restrictions are accounted for as restricted funds.

#### Resources expended

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the expenditure category. Costs of generating funds comprise the costs of generating voluntary income and the costs of trading for fundraising purposes. Charitable expenditure are those costs incurred in the delivery of activities and services for beneficiaries, including both costs that can be allocated directly to such activities and costs of an indirect nature necessary to support them. Governance costs are costs incurred in meeting constitutional and statutory requirements. All costs are allocated between expenditure categories on a basis designed to reflect the use of the resource.

### Fixed assets and depreciation

Items of furniture and equipment for the Centre's own use with individual values of less than £100 are written off as incurred. Other such items are capitalised and depreciated on a straight line basis over their useful economic lives as follows

Furniture 5 years Equipment 3 years

## Leasehold property and amortisation

The cost attributed to leasehold property includes expenditure incurred by the company and the value attributed to donated goods and services Leasehold property is amortised on a straight line basis over the 25 year term of the lease
