## Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### Tangible fixed assets

The company owns no fixed assets, but has entered into an agreement with Stratford Court (Farnborough) Freehold Limited to lease the flats known as Stratford Court at 29 Salisbury Road, Farnborough, Hampshire GU14 7AJ.

Premier Ridgemount Hampshire Ltd who developed the said properties, sold the freehold during 1977 to CPC & Mrs SA Ivil, who then subsequently sold on to Lisa Properties Limited in February 2001. The freehold has now been sold to Stratford Court (Farnborough) Freehold Limited, a company owned by all of the leaseholders. That company has extended the lease to Salisbury Road (Farnborough) Management Ltd for a term expiring on 28 September 3010. No Ground rent is charged.
