1 Executive summary

Progress of the liquidation

- Our work during the Period mainly focused on the recovery of claims under the Late Payments Act 2013, adjudication of unsecured claims and complying with statutory and administrative requirements
- Receipts and payments of the estate during the Period total £29,275 and £11,921, as at Period end respective cumulative totals are £390,571 and £193,557 with a Period end balance at bank of £60,352
- We have charged remuneration and incurred expenses in the Period amounting to £32,897 and £12,135, bringing the cumulative totals at Period end to £202,754 and £79,714 of which £114,057 and £79,501 has been paid.

Future of the liquidation

- The primary matters remaining to be dealt with are paying a first and final dividend to the unsecured creditors via the prescibed part and making a final distribution to HSBC.
- There are no future anticipated realisations
- In addition to remuneration charged, we estimate an additional £5,000 in remuneration to deal with the above remaining matters.

Dividend prospects

 We will be paying a first and final prescribed part dividend to the unsecured creditors of approximately 6p in the £ which is to be paid by 23 August 2023.

2 Assets

2.1 Realisation of assets

A statement of affairs detailing the Company's assets and liabilities, was provided to creditors by the director, as required, in the process of placing the Company into liquidation. The asset values are included in the abstract of the Joint Liquidators' receipts and payments at Appendix C.

Late payment settlements

Delv was instructed to make recoveries on behalf of the Company in respect of claims under the Late Payments Act 2013 and have recovered a total of £24,652. Delv has been paid fees of £7,276 in this regard.

Miscellaneous refund

During the Period we have received miscellaneous refunds due to the Company totalling £3,163.

Rates refund

A rates refund in the sum of £1,546 has been received from Harborough District council in the Period.

2.2 Assets remaining to be realised

There are no further assets to be realised.

3 Investigations into the affairs of the Company

3.1 Overview

We are investigating the Company's affairs to establish whether there are any potential undisclosed assets, antecedent transactions or income payments that require further investigation, taking into account the public interest, potential recoveries, the funds likely to be available to fund an investigation and the costs involved.

Based on the outcome of our investigations into the affairs of the Company to date, there are no matters identified that need to be reported to the creditors. However, we would be pleased to receive from any creditor any useful information concerning the Company that may assist us in our role as Joint Liquidators.

4 Creditors and dividend prospects

4.1 Secured creditors

HSBC hold a fixed and floating charge over the Company with an outstanding debt of £12.1 million.

Distributions totalling £136,662 have been paid to HSBC under its security. A small final distribution will be made to HSBC shortly, resulting in a shortfall against its lending.

4.2 Preferential creditors

There are no preferential creditors in this matter.

4.3 Unsecured creditors

We have received and agreed unsecured claims totalling £766,624.

Prescribed part

In accordance with section 176A of the Act, a prescribed part is to be set aside from the floating charge assets and made available to the unsecured creditors of the Company. The prescribed part calculation is applied to the net property available and is calculated at 50% of the first £10,000 of net realisations and 20% of all further amounts, up to a maximum prescribed part of £600,000.

Based on current information, the net property is estimated to be £196,974 resulting in a prescribed part dividend of £42,395 available to the unsecured creditors.

Dividend prospects

In accordance with the notice of intended dividend issued to creditors on 30 May 2023, we will be paying a first and final prescribed part dividend of approximately 6p in the £ by 23 August 2023.

Any distributions to be made to creditors who are designated under the UK sanctions regime (and the United States (US), European Union (EU) and other applicable sanctions regimes) (Sanctioned Creditors) will be frozen to comply with our legal obligations and will not be made availablt Sanoned Creditors unless, in very limited circumstances, the payment of the distribution is permitted by licenses issued by all applicable sanctions authorities.

6 Future strategy

6.1 Future conduct of the liquidation

This will include but not be limited to:

- paying an unsecured dividend to the creditors via the prescribed part.

Our next report to creditors will be issued no later than 22 September 2024, or earlier if the liquidation has been completed by that date.

Remuneration basis of the Joint Liquidators

Please note that although we previously reported that we would be seeking fee approval from the secured creditor, whilst this was obtained, in accordance with rule 18.20 of the Rules we were also required to seek the approval of the general body of creditors and this was completed in the prior period. On 2 June 2022 the creditors resolved that our remuneration be fixed according to the time properly spent by the Joint Liquidators and their staff with a fee estimate of £118,718.

During the Period remuneration has been charged, based on time costs incurred, totalling £32,897 represented by 115 hrs at an average of 286 £/hr (as shown in the 'Work done' section below). This brings cumulative remuneration charged as at Period end to £202,754. A description of the work done in the Period is provided in the respective section below.

Remuneration charged (time costs incurred) exceed the time costs in the fees estimate and expenses are in line with the expense estimate, both of which were provided to the creditors in our report dated 18 September 2020. The reasons for the excess are as follows:

- · Additional costs have been incurred in liaising with the secured creditor
- Unanticipated costs in communicating with Delv in respect of late payment settlements
- · Costs incurred liaising with creditors in respect of claims
- Associated costs in maintaining the administration of the liquidation.

As at Period end, payment from the estate totalling £114,057 has been made towards our remuneration.
