WRITTEN RESOLUTION

of

YORKSHIRE CABLE PROPERTIES LIMITED (the "Company") Registered Number 2951884

We, the undersigned, being the sole member of the Company, hereby resolve that the following resolution is passed as a written resolution in accordance with article 5 of the Articles of Association of the Company and agree that it shall be as valid and effective as if it had been passed as a special resolution at a general meeting of the Company duly convened and held.

IT IS RESOLVED THAT:

- 1. It is both for the benefit of the Company and in the Company's commercial interest to enter into a credit agreement (the "Credit Agreement") proposed to be entered into by General Cable Holdings Limited ("GCHL") as borrower; Banque Paribas, CIBC Wood Gundy PLC, NatWest Markets and The Toronto-Dominion Bank as Arrangers; the Banks (as defined therein); National Westminster Bank Plc ("NatWest") as Security Trustee; NatWest as Agent; and certain subsidiaries of General Cable Plc, including the Company, as Original Guarantors and to grant to the Finance Parties (as defined in the Credit Agreement) a guarantee of all the liabilities of the Obligors (as defined in the Credit Agreement) to the Finance Parties under the Finance Documents (as defined in the Credit Agreement).
- 2. It is both for the benefit of the Company and in the Company's commercial interest to enter into a composite debenture (the "Composite Debenture") proposed to be entered into by GCHL, the Original Guarantors and the Security Trustee for the purpose of securing all the liabilities of the Obligors to the Beneficiaries (as defined in the Security Trust Deed) under the Finance Documents.
- 3. It is both for the benefit of the Company and in the Company's commercial interest to enter in to a security trust deed (the "Security Trust Deed") proposed to be entered in to by GCHL, the Original Guarantors, NatWest as Trustee, NatWest as Agent and the Initial Beneficiaries (as therein defined).
- 4. It is both for the benefit of the Company and in the Company's commercial interest to enter into an intercreditor agreement (the "Intercreditor Agreement") proposed to be entered into by GCHL, the Original Guarantors, the Banks (as therein defined), NatWest, NatWest Specialist Finance Limited, Robert Fleming Leasing (Number 4) Limited, Lombard Commercial Limited, The Cable Corporation Limited, The Yorkshire Cable Group Limited, Banque Paribas, Dexia Municipal Bank PLC, Crédit Agricole Indosuez, Société Générale and others.

- 5. It is both for the benefit of the Company and in the Company's interest to enter into the documents listed in Schedule 1 hereto to which it is a party (the "Transaction Documents").
- 6. The terms of, and the transactions contemplated by, the Finance Documents and the Transaction Documents be and are hereby approved and that the Company enter into the Credit Agreement, the Composite Debenture, the Security Trust Deed, the Intercreditor Agreement, the Transaction Documents and any other Finance Document.
- 7. Regulation 24 of Table A incorporated into the Company's Articles of Association shall not apply where the transferee of the shares is a bank or other institution to whom the shares have been charged or any nominee of such bank or other institution or any purchaser from any such person and the certificate of any official of such bank or institution that the shares are so charged and that the transferee is such a person shall be conclusive evidence of such facts. On presentation of any such transfer the directors shall forthwith register the same.
