Directors' Report For the Year Ended 31 December 2021

The directors present their report and the audited financial statements for Home Depot (U.K.) Limited (the "Company") for the year ended 31 December 2021.

Principal activity

The principal activity of the Company during the year was that of procurement services to Home Depot Services LLC and other entities in the group of companies controlled by The Home Depot Inc. ("The Home Depot Group").

Results and dividends

The Profit and Loss Account is set out on page 6 and shows the profit for the year after taxation of €49,597 (2020 - €49,226).

Going Concern

In preparing the financial statements, the directors have considered the ability of the Company to continue as a going concern.

The parent company Home Depot International Inc. is the main creditor of the Company.

As the Company is a sourcing office for The Home Depot, Inc (the "Group"), it does not generate revenue and therefore projected figures are not available. As such, the directors have assessed the entity's ability to continue as a going concern in relation to the Group's analysis. As the Company's main source of business is to source product for the Group on a cost-plus margin model, the directors consider the analysis performed for the Group is relevant in evaluating any going concern considerations for the Company.

The directors performed a going concern analysis for the company and noted there were no conditions that gave rise to a substantial doubt about its ability to continue as a going concern over the next twelve months. Whilst there is uncertainty relating to the potential impact on the business and the incremental costs that may result due to COVID-19, management does not believe current conditions give rise to substantial doubt regarding the Group's ability to continue as a going concern over the next twelve months. The Group has measures in place to ensure liquidity, should conditions or events worsen to an extent that creates a substantial doubt about its ability to continue as a going concern. As of December 31, 2021, the Company currently has cash on hand of €696,962. In addition, the Group will provide support to the Company to satisfy expenses if they were to rise to a level that is unmanageable by the entity for a period of at least twelve months from the Balance Sheet date.

Therefore, the Company continues to adopt the going concern basis in preparing the annual report and financial statements.

Opinion

Notes to the Financial Statements For the Year Ended 31 December 2021

1. General information

Home Depot (U.K.) Limited ("the Company"), is a private company limited by shares, incorporated and domiciled in England and Wales under the Companies Act 2006 (registration number 02961334). The address of the registered office is Thames Tower, Station Road, Reading, Berkshire RG1 1LX and the nature of the Company's operations and its principal activity are set out in the Directors Report on page 1.

The following accounting policies have been applied:

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland, ("FRS 102") and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the Company's accounting policies (see note 3).

2.2 Financial Reporting Standard 102 - reduced disclosure exemptions

The Company has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by the FRS 102 for qualifying entities:

- the requirements of Section 7 Statement of Cash Flows;
- the requirements of Section 3 Financial Statement Presentation paragraph 3.17(d);
- the requirements of Section 11 Financial Instruments paragraphs 11.42, 11.44 to 11.45, 11.47, 11.48(a)(iii), 11.48(a)(iv), 11.48(b) and 11.48(c);
- the requirements of Section 12 Other Financial Instruments paragraphs 12.26 to 12.27, 12.29(a), 12.29(b) and 12.29A;
- the requirements of Section 26 Share-based Payment paragraphs 26.18(b), 26.19 to 26.21 and 26.23;
- the requirements of Section 33 Related Party Disclosures paragraph 33.7.

2.3 Going concern

2.4 Turnover

Turnover represents amounts receivable for services from other entities in The Home Depot Group and relates to services provided in Europe. Revenue is calculated based on a 10% mark up of costs incurred by Home Depot (U.K.) Limited.

2.5 Foreign currency translation

Functional and presentation currency

The Company's functional and presentational currency is Euros.

Transactions and balances

Foreign currency transactions are translated into the functional currency using the spot exchange rates at the dates of the transactions.

At each period end foreign currency monetary items are translated using the closing rate. Non-monetary items measured at historical cost are translated using the exchange rate at the date of the transaction and non-monetary items measured at fair value are measured using the exchange rate when fair value was determined.

Exchange rate differences are recognised in profit or loss in the period in which they arise.

2.6 Restricted stock

The Company is part of a group share based payment scheme involving the issue of restricted stock units to employees. When restricted stock units are granted to employees the fair value of those units is charged to profit or loss evenly over the period from the grant date to the date on which the units vest.

2.7 Interest receivable and similar income

Interest income is recognised in profit or loss using the effective interest method.

Notes to the Financial Statements For the Year Ended 31 December 2021

2. Accounting policies (continued)

2.8 Taxation

Tax is recognised in profit or loss except that a charge attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the Company operates and generates income.

2.9 Financial instruments

The Company only enters into basic financial instruments transactions that result in the recognition of financial assets and liabilities like accrued income, cash at bank, trade creditors, amounts owed to group undertakings and accruals.

Financial assets and liabilities are measured at cost and amortised cost and are assessed at the end of each reporting period for objective evidence of impairment. If objective evidence of impairment is found, an impairment loss is recognised in the profit or loss.

The Company does not hold financial instruments subject to the Amendments to FRS 102: Interest rate benchmark reform.

3. Judgements in applying accounting policies and key sources of estimation uncertainty

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the amount reported for assets and liabilities as at the balance sheet date and the amounts reported for revenue and expenses during the year. The nature of estimation means that actual outcomes could differ from those estimates.

There are no judgements or estimates which are deemed to have had a significant effect on the amounts \cdot recognised in the financial statements.

4. Turnover

Turnover is attributable to the principal activity of the Company.
