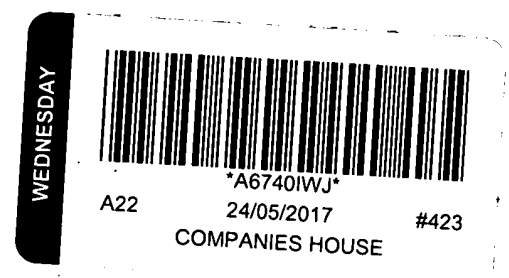

The company did not trade during the year and has not made either a profit or loss.


For the year ending 31 March 2017 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.
