WITNESSETH as follows:

The Principal Sum

1. This charge is for the principal sum of £9,200.00 plus interest at 5% fixed

Covenant to pay

2. The Company hereby covenants with The Trustees:

- 2.1 to pay on demand (i) All Monies Owing with interest thereon calculated from the due date for payment thereof and (ii) All Expenses with Interest thereon calculated from the date they are incurred

2.2 Repair

To keep the Property (or to procure that the Property is kept) in good and substantial repair, and in default The Trustees may enter and effect all necessary repairs, works of reinstatement and other works at the expense of the Company

2.3 Insurance of Property

To insure the property, against the normal comprehensive risks with an insurance company or underwriters of repute chosen by the Company and approved by the Trustees (such approval not to be unreasonably withheld) and in their full reinstatement value from time to time to the satisfaction of the Trustees.

2.4 Application of insurance monies

Subject to any prior charge to apply all monies received under any such insurances in making good the relevant loss or damage or (at the option of The Trustees) in or towards the discharge of All Monies Owing and All Expenses and Interest.

2.5 Compliance with legislation

2.5.1 To comply with all legislation relating to the Property or anything on or done on the Property.

2.5.2 To notify The Trustees forthwith in writing after the receipt by the Company of any notice, request for information, summons, complaint or letter sent by any person or statutory authority relating to the Property and, if requested by The Trustees, to produce a copy of the same to them.

2.6 Charging

Not to create, or purport to create, any other mortgage or charge on the Property without The Trustees prior written consent.

2.7 Indemnity

2.7.1 To indemnify and keep The Trustees indemnified from and against all actions, charges, claims, costs, damages, proceedings and other liabilities whatsoever occasioned by any breach by the Customer of the Company's obligations herein contained

2.7.2 Notwithstanding any provision to the contrary contained herein or at all, the liability of InvestAcc Pension Trustees Limited shall not be personal but shall be limited to the extent of the assets of the time being of the Anvil Homes Limited Directors Self Administered Pension Scheme and further InvestAcc shall have no liability after it ceases to be a Trustee of The Anvil Homes Limited Directors Self Administered Pension Scheme

Charge

3.1 The Company (to the full extent of the Company's interest in the property or its proceeds of sale) hereby charges by way of legal mortgage of all legal interests and otherwise by way of specific equitable charges and with full title guarantee (as a continuing security for the discharge on demand of All Monies Owing) All that the Property with the payments to The Trustees of:
