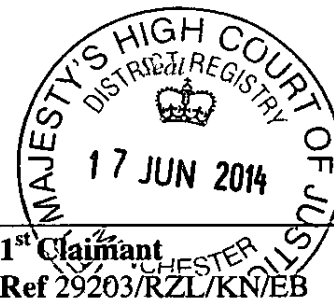

UPON THE APPLICATION by a Claim Form dated the 6th May 2014 of Mr Peter Nicolls the Claimant and creditor of the above named AGS Scaffolding Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Witness Statement of Miss Kate Sanderson and the exhibit thereto

AND on leave being given to amend the Claim Form to show the correct name of the Company as AGS Scaffolding Limited and re service being dispensed with

AND the Claimant by his solicitors undertaking that he will

- (A) Inform the Registrar of Companies of the title and Court reference number of the proposed litigation referred to in paragraph 8 of the Witness Statement of Kimberley Kirkby dated the 28th April 2014 immediately after issue
- (B) Inform the Registrar of Companies immediately on the conclusion of the proposed litigation or any appeal therefrom or the conclusion of the claim by any other means
- (C) Unless the proposed litigation is completed in the interim, at 6 monthly intervals from the date of the order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the proposed litigation

AND UPON the solicitors for the Claimant and for the Registrar of Companies
(the Defendant) both consenting to this Order

IT IS ORDERED THAT:

(1) the name of the above named AGS Scaffolding Limited be restored
to the Register of Companies

(2) the Company do continue in Creditors' Voluntary Liquidation

(3) if at the date of registration of this Order with the Registrar of
Companies the name of the Company is not available the Registrar
of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the
Companies Act 2006 change the name of the Company to
02979356 Limited

(4) an Office Copy of the Order be delivered to the Registrar of
Companies and pursuant to the above mentioned Act the Company
is thereupon to be deemed to have continued in existence as if its
name had not been struck off


(5) the Registrar of Companies do advertise notice of this Order in his
official name in the "London Gazette"

(6) the Claimant Mr Peter Nicolls do pay the Registrar of Companies


his costs of the said Application in the agreed sum of £300-00
