The Deed was originally made between the Mortgagor and the Mortgagee Pursuant to the Deed of Assignment (as defined below), the Mortgagee assigned all its rights, title, interest and benefit in and to, amongst other documents, the Deed in favour of the New Mortgagee (as defined below)

On 21 September 2009, solicitors (TLT LLP) for the New Mortgagee filed an application at Companies House to amend the register to reflect the changes made by the Deed of Assignment By letter dated 24 September 2009, Companies House confirmed that it was not able to register transfers of registered charges or record any change of chargee following a transfer

In order to secure the due payments of all amounts due or to become due under a loan agreement dated 7 December 2004 between the Mortgagor and Mortgagee (the "Loan Agreement"), which was subsequently assigned by the Mortgagee in favour of the New Mortgagee (as defined below) pursuant to the Deed of Assignment (as defined below), together with due and punctual performance and observance and compliance with the covenants, terms and conditions in the Loan Agreement, the Mortgage, the Deed and other security documents, the Mortgagor assigned sixty-four (64) shares in the Vessel, including without limitation the engines, machinery, boats, tackle, outfit, spare parts, fuel, consumable and other stores, belongings and appurtenances, and all additions, improvements and replacements thereto, in favour of the Mortgagee (as subsequently assigned to the New Mortgagee)

The Mortgagor also assigned to the Mortgagee, and subsequently to the New Mortgagee pursuant to the Deed of Assignment, the Insurances (as defined below), Earnings (as defined below) and Requisition Compensation (as defined below) relating to the Vessel pursuant to a deed of assignment of earnings, insurances and requisition compensation relating to the Vessel dated 19 January 2005 (the "Assignment of Earnings")
