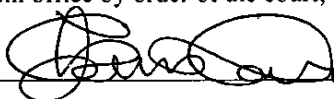

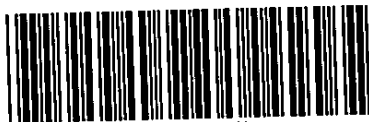

UPON THE APPLICATION of the Applicant filed on 20 May 2011

AND UPON READING:

- (1) the Witness Statements of Ian Brown dated 18 May 2011 and 22 May 2011,



- (2) the written consent of each person proposed to be a replacement office-holder, namely Daniel Francis Butters dated 16 May 2011 and William Kenneth Dawson dated 16 May 2011, and
- (3) the written consent of each person who currently holds office with the Applicants, namely Adrian Peter Berry dated 16 May 2011, Neil Matthews dated 16 May 2011, Angus Matthew Martin dated 18 May 2011, Nicholas Guy Edwards dated 18 May 2011, Neville Barry Kahn dated 18 May 2011, Christopher Richard Frederick Day dated 18 May 2011 and Philip Stephen Bowers dated 18 May 2011

IT IS ORDERED THAT:



1. Transfer of Cases to High Court, London

- (1) the cases numbered 1 to 21, 27 to 29 and 32 to 44 of the Schedules hereto be transferred to the High Court of Justice, Chancery Division, London for the purpose only of the substantive application;
- (2) the cases transferred pursuant to paragraph 1(1) be transferred back to the court from which they were transferred when this application has been dealt with by the court.

2. Block Transfer

- (1) in relation to the appointments set out in **Schedule 1** hereto, Ian Brown be removed and Daniel Francis Butters be appointed as his replacement and, where Schedule 1 lists another office holder remains in office, that person continue in office with the said Daniel Francis Butters;
- (2) in relation to the appointments set out in **Schedule 2** hereto, Ian Brown be removed and William Kenneth Dawson be appointed as his replacement and, where Schedule 2 lists another office holder remains in office, that person continue in office with the said William Kenneth Dawson;
- (3) Ian Brown be removed from office in respect of the appointments set out in **Schedule 3** hereto, and the remaining three office-holders for each case detailed in the said Schedule 3 continue in office;
- (4) the creditors and/or members in each case be notified of this order by advertisement in the London Gazette and at the time of the next statutory reporting requirement for each case;
- (5) that the costs of making this application shall be apportioned equally amongst the 50 cases listed in Schedules 1 to 3 hereto and that:

- (i) where the case relates to an administration appointment, the pro rata share of the cost of this application shall be payable as an expense of the administration; and
- (ii) where the case relates to any insolvency proceeding other than administration, the pro rata share of the cost of this application shall be payable as an expense of the insolvency proceedings,
