**Year ended 31 March 2018**

**1. General information**

The company is a private company limited by guarantee, registered in England and Wales. The address of the registered office is Fitzrovia House, 3rd Floor, 153-157 Cleveland Street, London, W1T 6QW.

**2. Statement of compliance**

These accounts have been prepared in compliance with Section 1A of FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

**3. Accounting policies**

**Basis of preparation**

The company ceased all trading activities in 2012 and has remained inactive in every year since including the current year. All bank accounts have been closed and the company retains no assets or liabilities.

**Income statement**

The company is dormant as defined by section 1169 of the Companies Act 2006. The company received no income and incurred no expenditure during the current year or prior year and therefore no income statement is presented within these accounts. There have been no movements in members funds during the current year or prior year.

**4. Company limited by guarantee**

The Company is limited by guarantee without any share capital. In the event of its being wound up each member is liable to contribute for payment of debts and liabilities of the company such amount as may be required not exceeding £1.

**5. Related party transactions**

No transactions with related parties were undertaken such as are required to be disclosed under the Financial Reporting Standard 102 Section 1A.
