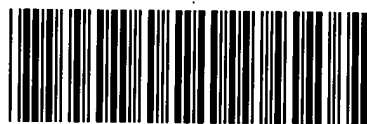

There was a loss of £902 (previous year - loss £632) for the year.




For the year ending 28th February, 2015, the company was entitled to exemption from audit under section 477 of the Companies Act 2006.
