Chairman's Report for the year ended 30 June 2019

On behalf of the Board of Directors it gives me great pleasure as Chairman, to present my third Annual Report.

Since my last report the club has achieved a great deal of success both on and off the court. Cast your mind back to last year, when or Saturday, 17th November 2018, Nick Matthew, OBE, three time British and World Open Squash Champion spent most of the day on court This was a landmark event for the club as Nick supervised clinics for adults and juniors and went on to play three exhibition matches with Harry Wyld, Andy Longman and Paul Boyle. Although, restricted by injury Nick threw himself into the day and stayed into the evening socialising and enjoying the sounds of the club band 'The Austin 7'. This truly was a remarkable day in the club's history and was the spring board for the fundraising towards our three main projects.

As you read this report, we have fully completed one of our three main projects, namely to refurbish the ladies showers and changing rooms which look superb.

Our second project, to renovate all of our courts is well underway and two fifths completed. Courts 1 and 5 have been transformed and fitted with underfloor heating ready for the colder months. I would like to thank John Jasinski of COGS Accountancy for his generous sponsorship in enabling the transformation of Court 5.

Our third project is to replace the viewing areas with glass balustrades. Only two more to install to complete this project. My thanks to Les Litwin of Antrica for his generosity in sponsoring the balustrade overlooking Court 2.

Sponsorship is so important to help us maintain and improve our standards. Five Guys continue to be our main team sponsors and their generosity enables all Club team members to be suitably kitted out when representing the club in matches.

The 2018/2019 squash and racket ball season proved to be yet another highly successful year for Beaconsfield. Again, we put out two club facket ball teams in Division 1 for the inter-county matches. Thanks go to both Dan Fernandez and Kevin Thorogood for their captaincy.

Our five men's teams and two ladies squash teams had great seasons.

The Ladies 1st team (under the captaincy of Sue Adams) had a mixed season due to injuries and ended up at the foot of Division 1.

Beaconsfield Stripes (the second team), captained by Nur Jones, won Division 2, winning all their matches. Congratulations.

In the 2018/2019 season, the club entered five teams in the South Bucks 'mens' league competitions. The Lions competed in the first livision, and had a highly successful season, winning the division in the final game of the final match against Chesham 1879! Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Turnover

Turnover represents the invoiced value, excluding value added tax, of goods sold and services provided to members, together with sponsorship, advertising and rental income.

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.
