We have audited the financial statements of Institute and Faculty Education Limited for the year ended 31 December 2007 which comprise the Profit and Loss Account, the Balance Sheet and related notes These financial statements have been prepared under the accounting policies set out therein

1. Accounting policies

(a) Accounting policies

The financial statements have been prepared under the historical cost convention and in accordance with applicable Accounting Standards in the United Kingdom

(b) Deferred taxation

Deferred tax is provided in full in respect of taxation deferred by timing differences between the treatment of certain items for taxation and accounting purposes The deferred tax balance has not been discounted

(c) Turnover and administrative costs

Turnover represents the invoiced amount of goods and services provided during the year, stated net of value added tax. Amounts invoiced but unearned at the year end are treated as deferred revenue

Sales of materials are recognised when the goods are shipped Sales of marking and tutorial services are recognised as the services are provided. Administrative costs are matched to services provided

(d) Audit fees

The audit fee of £3,700 (2006 £3,500) is met by Actuarial Education Co Ltd

2. Turnover

Turnover is attributable to one continuing activity, the provision of actiarial training

The company has appointed Actuarial Education Company Limited to provide this activity and the costs so arising are dealt with as administrative costs

9. Related party transactions

The company is the provider of training and educational services for students taking the professional examinations of the Institute of Actuaries and Faculty of Actuaries. The company wholly contracts out these services to Actuarial Education Company Limited and as a result accounts for a significant portion of that company's turnover. Some of this income is from students originating outside the United Kingdom and has been included as non UK turnover (see note 2 for details). At 31 December 2007 the balance outstanding owed by the company to ActEd was £394,280 (2006 £417,767).

At 31 December 2007 the company did not have a balance outstanding with the Institute or Faculty of Actuaries (2006 nil)

10. Ultimate parent company and controlling party

Institute and Faculty Education Limited is a 90% subsidiary undertaking of The Institute of Actuaries which is a body incorporated by Royal Charter The directors consider the Institute of Actuaries to be the ultimate parent company
