 From 2 May 2008, the Company's controlling and ultimate parent undertaking is Cadbury plc which, following the scheme of arrangement effected on that date, has become the new parent company of the Cadbury group Cadbury Schweppes plc has now been renamed Cadbury Holdings Limited and is a wholly owned subsidiary of Cadbury plc
- Group Accounts**
 As permitted by the Companies Act 1985, the Company, being a wholly owned subsidiary of a company incorporated in Great Britain, does not prepare group accounts

For the year ended 1 January 2006, the Company is entitled to the exemption from audit conferred by subsection (1) of Section 249AA of the Companies Act 1985 (the 'Act') and no notice has been deposited under subsection (2) of Section 249B of the Act requiring an audit of its accounts for the financial year
