1 Accounting Policies

Basis of measurement and preparation of accounts

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective April 2008.

Partnership Income is priority profit share from Limited Partnerships. This is accounted for on an accruals basis.

Expenses are accounted for on an accruals basis.

Investment in the Limited Partnership is held as a Fixed Asset Investment at the lower cost or net realisable value.

The Company is a wholly owned subsidiary of an EU company which publishes consolidated Financial Statements that include a consolidated cash flow statement and therefore is not required to produce a cash flow statement.

The Financial Statements contain information about Electra GP (Far East) Limited as an individual company and do not contain information as a parent of a group. The Company is exempt under section 400(1)(A) of the Companies Act 2006 from the requirement to prepare consolidated Financial Statements as its subsidiary undertakings are included by full consolidation, or the reasons for their exclusions, in the Financial Statements of its parent, Electra Kingsway Holdings Limited, a Company registered in England and Wales.

Foreign currency transactions are recorded at the rate of exchange ruling at the date of the transaction. Foreign currency investments are translated at historical exchange rates, and foreign currency assets and liabilities (other than investments) are translated at the exchange rate at the year end. The resulting exchange differences at the year end are taken to the profit and loss account.
