- (2) all books papers and other records in the custody, power or control of the First and/or Second Respondent that relate to the Respondents' administration of the insolvent estates including all paper records and all records held in electronic format to include but not be limited to time records, all emails sent and received by the Respondents in relation to the administration of the insolvent estates and all records held on the IPS system; and
- (3) all bank documents including pass books, cheque books, paying-in books, bank statements and all other monies and assets belonging to the insolvent estates.
