CHARGES

- 1. The Company charges with full title gurantee to Marcol:
 - (a) by way of legal mortgage, all freehold and leasehold property now vested in the Company, together with all buildings, fixtures (including trade fixtures) and fixed plant and machinery from time to time in that property;
 - (b) by way of fixed charge, all estates or interests in any freehold and leasehold property of the Company (not being property charged by clause 2.2.1) now and in the future vested in the Company together with all buildings, fixtures (including trade fixtures) and fixed plant and machinery from time to time on that property;

NEGATIVE PLEDGE

- 2. The Company shall not other than with the previous written consent of Marcol:
 - (a) (except for charges in favour of Marcol created under or pursuant to this Debenture and except for charges created to secure finance provided to the Company for the purposes of the Project and arranged by Marcol) create or

permit to subsist any mortgage, charge or lien on any of its undertaking or assets;

- (b) sell, transfer or otherwise dispose of its undertaking and other assets or any part of them, except by getting in and realising them in the ordinary and proper course of its business;
- (c) pull down or remove all or any part of the buildings forming part of the Property or sever, unfix or remove any of the fixtures on the Property nor (except for necessary repairs or the substitution of full value replacements) remove any plant and machinery from the Property (provided that any such action taken for the purposes of the Project and in accordance with the Project Plan approved by Marcol shall, the for avoidance of doubt, be deemed to have occurred with Marcol's consent for the purposes of this Debenture);
- (d) deal with its book or other debts or securities for money except by getting in and realising them in the ordinary and proper course of its business, but so that this exception shall not permit the realisation of debts by means of block discounting or factoring; or
- (e) grant or accept a surrender of any lease or licence of or part with or share possession or occupation of the Property or any part of it.
