 - 8 2 3 executed by a receiver or manager appointed by or on behalf of any Secured Institution or its nominee, under any such security,
 - 8 2 4 and furthermore, notwithstanding anything to the contrary contained in these Articles
 - 8 2 5 no transferor of any shares in the Company or proposed transferor of such shares to a Secured Institution or to its nominee,
 - 8 2 6 no Secured Institution or its nominee, and
 - 8 2 7 no receiver or manager appointed by or on behalf of a Secured Institution or its nominee, shall be required to offer the shares which are or are to be the subject of any such transfer to the shareholders for the time being of the Company or any of them, and no such shareholder shall have any right under these Articles or otherwise to require such shares to be transferred to them whether for consideration or not"
- 2 That the existing articles of association shall be renumbered accordingly
