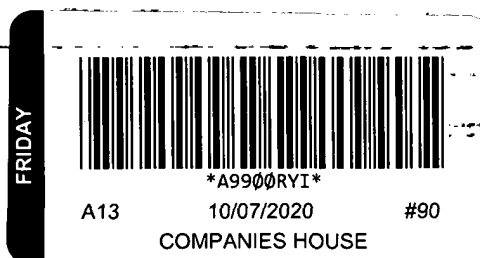

**ORDER**

**UPON** the Application of Zelf Hussain, Robert Nicholas Lewis and Rachel Wilkinson (the “Joint Administrators”), acting as Joint Administrators of Laura Ashley Investments Limited (the “Company”);

**AND UPON** reading the evidence;

**AND UPON** hearing Madeleine Jones, Counsel for the Joint Administrators;

**IT IS ORDERED THAT:**

- (1) Anthony John Wright and Paul Allen of FRP LLP be appointed as Fourth and Fifth Joint Administrators of the Company;
- (2) For the purposes of Rule 3.69 of the Insolvency (England & Wales) Rules 2016 the Fourth and Fifth Joint Administrators shall file with the Court and deliver to the Registrar of Companies notice of their appointment setting out the information required by Rule 3.24, adapted in accordance with Rule 1.9 to the circumstances of the case, clearly identifying that the appointment is as additional administrators;
- (3) For the purposes of paragraph 100(2) of Schedule B1 to the Act, the Fourth and Fifth Administrators and the other Joint Administrators may exercise any of the powers conferred on them by the Act jointly or individually;
