## **Directors' report**

The directors present their report and financial statements for the year ended 30 June 2014.

#### Results and dividends

The loss for the year amounted to £1,308 (2013– profit of £511,578). No dividend has been declared during the year (2013 - £875,000).

### Principal activity and review of the business

The company's principal activity during the year ended 30 June 2014 was that of an investment holding company. The company continues to own 50% of the joint venture AETN UK which is jointly operated with BSkyB History Limited.

### Disclosure of information to the auditors

# Statement of directors' responsibilities

We have audited the financial statements of A&E Television Networks (UK) Limited for the year ended 30 June 2014 which comprise the Profit and Loss Account, the Statement of Total Recognised Gains and Losses, the Balance Sheet and the related notes 1 to 12. ### 1. Accounting policies

### Basis of preparation

The financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards.

#### Going concern

The financial statements have been prepared on a going concern basis. The directors have no reason to believe that the company will not have sufficient resources to meet its liabilities in the future as and when they fall due.

#### Statement of cash flows

The company has taken advantage of the concession in FRS 1 'Statement of cash flows' which exempts a company from the requirement to prepare a statement of cash flows on the grounds that the company is small as defined in companies' legislation.

#### Investments

The investments are valued at cost unless, in the directors' opinion, there is any impairment in the carrying value.

The carrying value of fixed asset investments are reviewed for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable.

#### Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more, or a right to pay less or to receive more, tax, with the following exception:

Deferred tax assets are recognised only to the extent that the directors consider that it is more likely
than not that there will be suitable taxable profits from which the future reversal of the underlying
timing differences can be deducted.

Deferred tax is measured on an undiscounted basis at the tax rates that are expected to apply in the periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date.

### Foreign currencies

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are retranslated at the rate of exchange ruling at the balance sheet date.

All differences are taken to the profit and loss account.

#### 2. Auditor's remuneration

Auditor's remuneration has been borne by another group undertaking in both the current and prior years.

### 3. Staff costs

There were no employees in the company, other than the directors. None of the directors, who are remunerated by other group undertakings, received any remuneration for services to the company during the current and prior year.

The deferred tax asset, which has been calculated at 20% (2013 - 23%) has not been recognised due to the uncertainty surrounding the availability of future taxable profits to enable its reversal.

The Finance Act 2013, which provides for reductions in the main rate of corporation tax from 23% to 21% effective from 1 April 2014 and to 20% effective from 1 April 2015, was substantively enacted on 2 July 2013. These rate reductions have been reflected in the calculation of the unrecognized deferred tax at the balance sheet date.
