1. Accounting policies

General information

A&E Television Networks (UK) Limited is a private company limited by shares. It is registered in England, registration number 3113371. The registered address is 5th Floor, 6 St Andrew Street, London, EC4A 3AE.

Basis of preparation

The financial statements are prepared under the historical cost convention and in accordance with and comply with Section 1A Small Entities of Financial Reporting Standard 102.

A summary of the accounting policies is set out below.

Deferred tax assets are recognised only to the extent that the directors consider that it is more likely
than not that there will be suitable taxable profits from which the future reversal of the underlying
timing differences can be deducted.

Deferred tax is measured on an undiscounted basis at the tax rates that are expected to apply in the periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date.

Monetary assets and liabilities denominated in foreign currencies are retranslated at the rate of exchange ruling at the balance sheet date.
