

NOTES TO THE ACCOUNTS AS AT 31ST OCTOBER 1998

1. <u>ACCOUNTING POLICIES</u>

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's accounts.

Basis of Preparation

The accounts have been prepared under the historical cost convention, and in accordance with applicable accounting standards. Under Financial Reporting Standard 1, the company is exempt from the requirement to prepare a cash flow statement on the grounds of its size.

Fixed Assets

The company acquire the freehold interest in Acris Court, Acris Street, London SW18 2QS. The Directors are of the opinion that the market value of the freehold interest in this property is not less than the cost and therefore the company has not charged depreciation for this year.

Service Charges

The residents' company is currently administered by Priority Estate Management. Service charges are charged to the tenants each year based on the budgeted expenditure.

Profit and Loss Reserve

The funds held in the profit and loss reserves are held as a provision to cover future maintenance costs.

Taxation

The company is a non-profit making enterprise and surpluses or deficits arising as a result of differences between service charges levied (based on estimated costs) and actual costs incurred do not fall within the scope of corporation tax. Tax is payable on investment income only.

Turnover

Turnover represents the amounts (excluding value added tax) derived from the provision of services to customers during the year.
