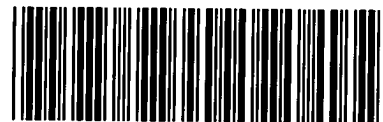

## **Directors' Report**

The directors present the audited financial statements of ALD Automotive Group Limited ("the Company") for the year ended 31 December 2022. The Company is a limited liability company domiciled and incorporated in the United Kingdom.

### **Results and dividends for the year**

The overall profit for the year after taxation amounted to £116,809k (2021: £40,349k). At the balance sheet date, total assets of the Company stood at £22,945k (2021: £22,945k) with net assets of the same amount as the Company had no liabilities.

During the year, a dividend of £116,809k (29.2p per share) was paid (2021: £40,349k, 10.1p per share). Subsequent to the balance sheet date no dividend is proposed in relation to the year ended 31 December 2022.

### **Section 172 (1) statement – Directors' duty to promote success of the Company**

In accordance with Section 172 of the Companies Act 2006, the directors of the Company must act in the way that they consider, in good faith, would be most likely to promote the success of the Company for the benefit of its members as a whole. The Company continues to be an investment company, holding the entire share capital of ALD Automotive Limited ("The Subsidiary"). The directors consider that the Company's key business relationships are with The Subsidiary and its own parent undertaking, so the Company and its key stakeholders are under common control. The only transactions in the year were the receipt of dividend income from The Subsidiary and dividend payment to the immediate parent of the Company.

### **Directors**

The directors of the Company in office during the year and to date of approval of these financial statements are as listed on page 1.

No director held any beneficial interest in the issued share capital of the Company at 31 December 2022. In accordance with the terms of the Articles of Association, the directors are not subject to retirement by rotation.

All directors have the benefit of a contract of indemnity. This was in force during the whole of the year.

### **Going Concern**

The Company continues to be an investment holding company and did not trade during the year. The directors do not expect any changes to the business for the period to June 2024. The directors believe the value in use of the investment in The Subsidiary is higher than its carrying value and therefore the investment in the equity is not impaired. They therefore consider there to be no material uncertainty and the Company will continue to be a Going Concern for a period to 30 June 2024.

### **Climate Change**

The Company has considered the potential impacts of climate change on the financial statements, including on key assumptions and estimates used in the valuation of reported assets and liabilities, and concluded that there are no material implications at this time. Impacts of climate change will remain under review by the Directors.

### **Disclosure of information to the auditor**

So far as each person who was a director at the date of approving this report is aware, there is no relevant audit information, being information needed by the auditor in connection with preparing its



The Company is an intermediate holding company with all income attributable to dividends from ALD Automotive Limited. During the year, the Company received a dividend of £116,809k (2021: £40,349k) from The Subsidiary.

The Company's principal activity remains that of a holding company and the directors expect this to continue for the foreseeable future.

### **Key performance indicators**


Given the straightforward nature of the business, the Company's Directors are of the opinion that analysis using key performance indicators is not necessary for an understanding of the development, performance, or position of the business

#### ***Explanation as to what extent the audit was considered capable of detecting irregularities, including fraud***


Irregularities, including fraud, are instances of non-compliance with laws and regulations. 

## **1. ACCOUNTING POLICIES**

### **Basis of preparation**

The financial statements are prepared under the historical cost convention, as modified by the revaluation of financial assets and liabilities at fair value through income as set out in the relevant accounting policies and are prepared in accordance with International Financial Accounting Standards in conformity with the requirements of the Companies Act 2006.

The Company continues to be an investment holding company and did not trade during the year. The directors do not expect any changes to the business for the period to 30 June 2024. Thus, they continue to adopt the going concern basis of preparation for the financial statements.

The directors believe the value in use of the investment in The Subsidiary is higher than its carrying value and therefore the investment in The Subsidiary is not impaired. The going concern basis of preparation of the financial statements has been adopted for the financial statements of The Subsidiary and as such the directors have a reasonable expectation that it has adequate resources to continue in existence for the period to 30 June 2024.

The presentation currency is sterling (GBP). Amounts disclosed are rounded to the nearest £1,000.

The Company is exempt by virtue of International Financial Reporting Standard ("IAS") 10 'Consolidated Financial Statements' from the requirement to prepare group financial statements due to the ultimate parent company preparing financial statements that are publicly available (see note 8). These financial statements present information about the Company as an individual undertaking and not about its Group.

### **Investments**

Investment in The Subsidiary is held initially at cost, being the fair value of the consideration given to acquire the holding. Investments are subsequently recorded at cost plus any further capital contributions and less any provision for impairment in value. The carrying value is reviewed for impairment annually.

### **Dividend income**

Dividend income is recognised when the right to receive payment is established. This is when the Board of The Subsidiary approves the dividend based on the entity's statutory results.

In May 2023, ALD, the France-headquartered parent company of ALD Automotive Group acquired 100% of the share capital and voting rights of LP Group B.V., the holding company of LeasePlan Corporation N.V. ("LeasePlan"). The combination of ALD and LeasePlan is expected to create a leading global mobility player, strongly positioned to lead the digital transformation of the industry and capture mobility sector growth across geographies, including the UK.
