
**IT IS RESOLVED** THAT pursuant to Section 21 of the Companies Act the regulations contained in the document submitted to this meeting and, for the purpose of identification, signed by the chairman hereof be approved and adopted as the articles of association of the company in substitution for and to the exclusion of all the existing articles thereof.

**IT IS RESOLVED** THAT the company creates new classes of share known as Class Ordinary A Shares of £1 each and Class Ordinary B Shares of £1 each with the rights and obligations being laid down as in the new Articles of Association for the Company

**IT IS RESOLVED** THAT the Directors are generally and unconditionally authorised for the purposes of section 551 of the 2006 Act to exercise any power of the Company to allot and grant rights to subscribe for or convert securities into shares of the Company up to the allotment threshold of £2,000 in accordance with Article 24 of the Articles of Association at any time or times during the period of five years from the date of this written resolution and at any time thereafter pursuant to any offer or agreement made by the company before the expiry of this authority. The authority hereby given may at any time (subject to the said section 551) be renewed, revoked or varied by ordinary resolution.

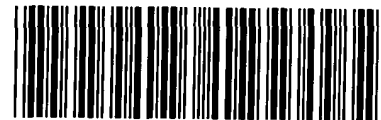
