In this statutory declaration defined terms shall have the meanings set out below:

"First Supplemental WB Group Deed of Charge"

means a deed of charge to be entered into between, inter alia, Welcome Break Group Limited, Welcome Break Finance PLC and Bankers Trustee Company Limited.

"WB Group Secured Parties"

means, inter alia, Welcome Break Finance PLC, National Westminster Bank PLC and Bankers Trustee Company Limited.

"Issuer/WBG Facility Agreement"

means a facility agreement to be entered into between inter alia, Motorway Services Limited, Welcome Break Group Limited, Welcome Break Limited, Welcome Break Finance PLC, the Ancillary Facilities Provider and the Security Trustee.

"Master Definitions and Construction Schedule"

means the definitions schedule as amended referred to in the Issuer/WBG Facility Agreement and the WB Group Deed of Charge.

"Security Trustee"

is Bankers Trustee Company Limited.

"WB Group Deed of Charge"

means a deed of charge to be entered into between, inter alia, Welcome Break Group Limited, Welcome Break Finance PLC and the Security Trustee.

"Ancillary Facilities"

means certain facilities including, without limitation, overdraft facilities, short term loans, guarantee, bonding or documentary or standby letter of credit facilities.

"Ancillary Facilities Provider"

is National Westminster Bank Plc.

"Property"

Appendix 2 - Principal Terms on which the Financial Assistance will be given

The First Supplemental WB Group Deed of Charge;

Pursuant to the First Supplemental WB Group Deed of Charge, Welcome Break Group Limited will grant a first fixed charge over the Property (as more fully described below) to the Security Trustee for the payment or discharge of each liability which Welcome Break Group Limited, Welcome Break Limited and Motorway Services Limited will have to the Security Trustee (whether on its own account or as trustee for the other WB Group Secured Parties) or any of the other WB Group Secured Parties (whether solely or jointly with one or more persons and whether as principal or surety) under or pursuant to the WB Group Deed of Charge, the First Supplemental WB Group Deed of Charge, the Issuer/WBG Facility Agreement or the Master Definitions and Construction Schedule and pay to the Security Trustee when due and payable every sum (of principal, interest or otherwise) owing due or incurred by Welcome Break Group Limited, Welcome Break Limited and Motorway Services Limited (whether on its own account or as trustee for the other WB Group Secured Parties) or any of the other WB Group Secured Parties in respect of any such liabilities (the "Secured Liabilities").

As security for the Secured Liabilities, Welcome Break Group Limited will charge by way of legal mortgage in favour of the Security Trustee, all its rights, title, interest and benefit present and future, in and to the Property and all estates or interests in any other freehold or leasehold property now or hereafter belonging to it.
