

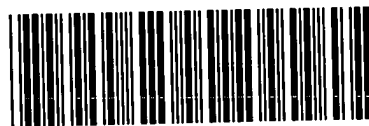

1. PRINCIPAL ACCOUNTING POLICY

The Company's financial statements have been prepared in compliance with United Kingdom Accounting Standards, including Financial Reporting Standard 102, "The Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland" ("FRS 102") and the Companies Act 2006.

FRS 102 allows an entity to apply certain recognition and measurement exemptions to standards requirements. The entity being dormant, it has applied the exemptions available under the standard which allows a Company to 'retain its accounting policies for reported assets, liabilities and equity at the date of transition (being 1 April 2014) until there is any change to those balances or the Company undertakes any new transactions. These financial statements have been prepared under the historical cost convention.
