1 ACCOUNTING POLICIES

Going concern

The company continues to be an investment holding company and has not traded during the current year and preceding period. The directors have considered future sources of funding and expenditure and are of the opinion that no material uncertainties that may cast significant doubt about the ability of the company to continue as a going concern have been identified.

Basis of preparation

The financial statements have been prepared under the historical cost convention, as modified by the revalluation of certain fixed assets, and have been prepared in accordance with the Companies Act 2006.

In accordance with Financial Reporting Standard No 18 "Accounting Policies" the company's directors have reviewed the company's accounting policies and confirm that they continue to be the most appropriate.

A summary of the significant accounting policies which have been consistently applied in the current and the preceding year is set out below.

Trading status

The company was dormant throughout the current and previous year.

Exemption from preparing a cash flow statement

The company has taken advantage of the exemption conferred by Financial Reporting Standard No 1 (Revised 1996), from presenting a cash flow statement on the grounds that it qualifies as a subsidiary undertaking, 90% or more of those voting rights are controlled within the group and consolidated financial statements (which includes the company) are publicly available.

Exemption from preparing group accounts

The financial statements present information about the company as an individual undertaking and not about its group. The company is a wholly owned subsidiary of of the parent company Pineapple Corporation Plc, a company incorporated in England and Wales. Pineapple Corporation Plc prepares consolidated financial statements which includes the company and its subsidiary undertakings. The company has therefore taken advantage of the exemptions provided by section 400 of the Companies Act 2006 not to prepare group accounts.

Fixed asset investments

Investments in subsidiaries are stated at historical cost less provision for impairment.

The carrying value of the investments in subsidiary undertakings are reviewed as necessary for impairment. Impairment is calculated as the difference between the carrying value and the estimated value-in-use or disposal value if higher. Value-in-use represents the present value of future expected cash flows discounted on a pre-tax basis. the net book amount of the investment is written down where impairment is identified.

1 ACCOUNTING POLICIES (CONTINUED)

Financial instruments

Financial instruments are classified and accounted for, according to the substance of the contractual arrangement, as financial assets, financial liabilities or equity instruments. An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities.

2 AUDITOR'S REMUNERATION

The auditors remuneration for the year ended 31 March 2015 was borne by Pineapple Corporation plc, the company's parent undertaking.

3 DIRECTORS' REMUNERATION

No remuneration was paid to the directors during the year (2014: £nil).
