ON the application of Stephen Gordon Franklin dated 6 November 2019

AND ON reading the evidence

Pursuant to Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (SI 2016/1024) **IT IS ORDERED THAT:**

1. STEPHEN GORDON FRANKLIN ("Outgoing Officeholder") be removed from office pursuant to r12.36(2) Insolvency Rules 2016 in respect of each of the cases listed in Schedule A (attached to this order) (**block transfer cases**) from the date of this order.
2. JASON CALLENDER ("Replacement Officeholder") be appointed as sole and / or joint replacement officeholder in respect of each of the block transfer cases listed in Schedule A from the date of this order.
3. The creditors in each of the block transfer cases listed in Schedule A be notified of this order by advertisement published in the London Gazette within 28 days of this

Order.

4. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in Schedule A who has an objection to this order shall have 28 days from the date of the advertisement in the London Gazette to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedule A until further or other order by the court.
5. The Replacement Officeholder shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations listed in Schedule A of the terms of this order as soon as reasonably practicable.
6. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedule A (attached to this order).
