AND UPON READING the Witness Statements filed in support of the application, the Witness Statement filed by the Respondent and the letter from the Respondent dated 14 March 2012

AND UPON the Respondent having automatically vacated office as Trustee in Bankruptcy over each of the individuals listed in Schedule A to this Order pursuant to Section 298 (6) of the Insolvency Act 1986 upon ceasing to be qualified to act as an insolvency practitioner

AND UPON the Respondent having automatically vacated office as Liquidator over each of the Companies listed in Schedule B to this Order pursuant to Section 172 (5) of the Insolvency Act 1986 upon ceasing to be qualified to act as an insolvency practitioner

AND UPON the Respondent having automatically vacated office as Liquidator over each of the Companies listed in Schedule C to this Order pursuant to Section 171 (4) of the Insolvency Act 1986 upon ceasing to be qualified to act as an insolvency practitioner

IT IS ORDERED THAT.

- 1 The cases listed in Schedules A to D attached to this Order, in so far as they are currently proceedings in a County Court or in a District Registry, be transferred to the High Court of Justice for the purpose of making the orders listed below
- 2 Kevin Hellard and Amanda Wade both of Grant Thornton UK LLP, 30 Finsbury Square, London, EC2P 2YU ("the Successor Practitioners") be appointed as the Joint Trustees in Bankruptcy (such appointment to be joint and several) of each of the individuals listed in Schedule A to this Order in place of the Respondent with immediate effect
- 3 The Successor Practitioners be appointed as the Joint Liquidators (such appointment to be joint and several) of each of the Companies listed in Schedule B to this Order in place of the Respondent with immediate effect
- 4 The Successor Practitioners be appointed as the Joint Liquidators (such appointments to be joint and several) of each of the Companies listed in Schedule C to this Order in place of the Respondent with immediate effect
- 5 The Respondent be removed from the office of Supervisor of each of the Individual Voluntary Arrangements listed in Schedule D to this Order with immediate effect

- 6 The Successor Practitioners be appointed as the Supervisors (such appointment to be joint and several) of the Individual Voluntary Arrangements listed in Schedule D to this Order in place of the Respondent with immediate effect
- 7 The Successor Practitioners give notice of the final meetings of creditors to be held in relation to the companies listed at numbers 1, 5, 8 to 13, 15, 19, 20, 23, 24, 26 to 28, 34, 35, 37 to 43, 45, 47, 48, 50, 54, 57, 58, 60, 62, 63, 71, 72 and 76 to 80 of Schedule C to this Order by way of advertisement
- 8 The Respondent do, within 14 days of the date of this Order, provide to the Applicant an affidavit providing details (to the best of the Respondent's knowledge and belief) of any estates which are not listed in Schedules A to D to this Order and in respect of which the Respondent has been appointed as office holder under the Insolvency Act 1986 (whether such appointments are or were held solely or jointly) from 5 October 2009 to the date of this Order irrespective of whether the Respondent has now received his release and/or discharge from office
- 9 In relation to any estates over which the Respondent is or was appointed as the office holder which are not listed in Schedules A to D to this Order, that the Applicant has permission to restore this application for the purpose of transferring to the Successor Practitioners those appointments and the appointments of any other person(s) with whom the Respondent may hold or have held office jointly (subject, where appropriate, to that person/those persons consenting to the transfer of appointment(s))
- 10 The Respondent be prohibited from drawing any remuneration or withdrawing any other monies whatsoever from the estates of the cases identified in Schedules A to D to this Order without the permission of the Court or the written consent of the Successor Practitioners
- 11 In respect of any estates over which the Respondent remains the appointed office holder and which are not transferred to the Successor Practitioners, the Respondent be and is hereby prohibited from drawing any remuneration or withdrawing any other monies whatsoever from any such estates without the permission of the Court or the written consent of the Successor Practitioners
- 12 The Respondent do forthwith transfer to the Successor Practitioners any monies or other assets in his possession, custody, power or control which belong to any of the insolvent estates listed in Schedules A to D to this Order

- 13 The Respondent do deliver up to the Successor Practitioners any documents, materials and articles in his possession, custody, power or control which are listed in Schedule E to this Order.
- 14 The Respondent must in so far as it is within his power to do so permit any of the following persons
- (a) the Successor Practitioners, their employees or agents, and/or
 - (b) members and/or employees of Gateley LLP (the Applicant's solicitors),
- to attend at the Respondent's business premises at Charles Lane Mews, 63-64 Charles Lane, St John's Wood, London NW8 7SB ("the Premises") between 2pm and 6pm on 15 March 2012 and 9am and 6pm on 16 March 2012 so that the Respondent can deliver up (as per paragraph 13 above) for safekeeping to the Successor Practitioners all the documents, materials and articles which are listed in Schedule E to this Order
- In addition, the Respondent must permit access to the Premises to the Successor Practitioners' IT consultants between 2pm and 6 pm on 15 March 2012 and 9am and 6pm on 16 March 2012 to obtain an image of the Respondent's computer equipment (if any) at the Premises including, but not limited to the Respondent's server
- 15 In the event that it becomes necessary for any of the persons mentioned in paragraph 14 above to leave the Premises before they have collected all the documents, materials and articles which are listed in Schedule E to this Order (or as regards the IT Consultant, before he / she has obtained an image of the Respondent's computer equipment) the Respondent must allow them to re-enter the Premises immediately upon their seeking re-entry on the same or next business day between 9am and 6pm
- 16 The Successor Practitioners shall give notice of their appointments
- 16 1 to all creditors of the estates listed in Schedules A, B and C of this Order within 28 days of the date of this Order by way of advertisement in the London Gazette,
- 16 2 to all creditors of the estates listed in Schedule D of this Order within 28 days of date of this Order in writing by First Class Post
- 17 All creditors of the estates listed in Schedule A to D of this Order do have permission to apply to the Court, on notice to the Applicant, within 28 days of the

abovementioned (in paragraph 16) advertisement (in the case of the creditors of the estates listed in Schedules A to C of this Order) or within 28 days of notice being posted (in the case of the creditors of the estates listed in Schedule D of this Order) for the purpose of applying to vary or discharge the Order in so far as it affects the estate or estates of which they are a creditor

- 18 The time for service of the Application Notice upon the Respondent be abridged
- 19 There be no order as to costs save that the Applicant's costs of this Application be charged as a cost or expense of the estates listed in Schedules A to D of this Order (each estate to bear an equal share, but with no estate having to bear an amount exceeding 10% of available funds in that estate)
- 20 The Respondent is not entitled to any indemnity in respect of the costs of this Application and, accordingly, the Respondent is not entitled to charge those costs as a cost or expense of the estates listed in Schedules A to D of this Order
- 21 Permission to apply
