- (3) That Ed Boyle, Christine Lavery and Jonathan Pope all of KPMG LLP be
appointed as joint liquidators of the Company pursuant to section 140 Insolvency
Act 1986 (the "Joint Liquidators"),
- (4) That any act required or authorised under any enactment to be done by a
liquidator may be done by any, some or all of the Joint Liquidators pursuant to
section 231 of the Insolvency Act 1986,

- (5) That the Joint Administrators' appointments of the Company cease to have effect from the date the Company is wound up by the Court,
