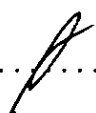

2. It was resolved that the director(s) be instructed to file the relevant form(s) 288 with Companies House.

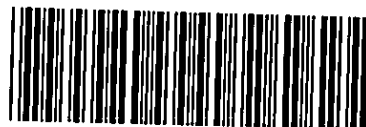
