Section 3 has been amended accordingly so please treat the original submission as an error.

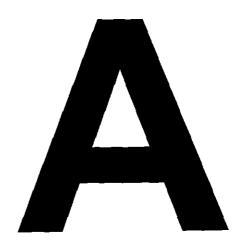
